FINAL AMENDMENT TO TENDER OFFER STATEMENT

This Amendment No. 2 supplements and amends the Schedule TO filed with the Securities and Exchange Commission onMay 11, 2015, as supplemented and amended on June 24, 2015, by HMS Income Fund, Inc., an externally managed, non-diversified, closed-end management investment company incorporated in Maryland (the "Company"), in connection with the offer by the Company to purchase up to 578,584.51 shares of its issued and outstanding common stock, par value \$0.001 per share (the "Shares"). The tender offer was made upon, and subject to, the terms and conditions set forth in the Offer to Purchase, dated May 11, 2015, and the related Letter of Transmittal (together, the "Offer"). The Offer terminated at 5:00 P.M., Central Time, on June 19, 2015, and 52,799.32 Shares were validly tendered and not withdrawn pursuant to the Offer so such date. In accordance with the terms of the Offer, the Company purchased on June 24, 2015 (the initial funding date)48,799.32 Shares validly tendered and not withdrawn on such date, and, on July 9, 2015, the Company purchased an additional 4,000.00 Shares validly tendered and not withdrawn (the final funding date), in each case at a price of \$8.71 per Share, which was the net asset value per share as of June 23, 2015, for an aggregate purchase price of approximately \$459,882.07.
