## FINAL AMENDMENT TO TENDER OFFER STATEMENT

This Amendment No. 1 supplements and amends the Schedule TO filed with the Securities and Exchange Commission on February 16, 2016 by HMS Income Fund, Inc., an externally managed, non-diversified, closed-end management investment company incorporated in Maryland (the "Company"), in connection with the offer by the Company to purchase up to 1,220,952.85 shares of its issued and outstanding common stock, par value \$0.001 per share (the "Shares"). The tender offer was made upon, and subject to, the terms and conditions set forth in the Offer to Purchase, dated February 16, 2016, and the related Letter of Transmittal (together, the "Offer"). The Offer terminated at 5:00 P.M., Central Time, on March 25, 2016, and 200,447.59 Shares were validly tendered and not withdrawn pursuant to the Offer as of such date. In accordance with the terms of the Offer, the Company will purchase on March 30, 2016 (the funding date) all 200,447.59 Shares validly tendered and not withdrawn at a price of \$7.62 per Share, which is the net asset value per share as of March 29, 2016, for an aggregate purchase price of approximately \$1,527,410.65.
