This Amendment No. 2 supplements and amends the Schedule TO filed with the Securities and Exchange Commission onJuly 13, 2018 and supplemented and amended on September 4, 2018 by HMS Income Fund, Inc., an externally managed, non-diversified, closed-end management investment company incorporated in Maryland (the "Company"), in connection with the offer by the Company to purchase up to 1,013,133.18 shares of its issued and outstanding common stock, par value \$0.001 per share (the "Shares"). The tender offer was made upon, and subject to, the terms and conditions set forth in the Offer to Purchase, dated July 13, 2018, and the related Letter of Transmittal (together, the "Offer"). The Offer terminated at 5:00 P.M., Central Time, on August 24, 2018, and 975,686.154 Shares were validly tendered and not withdrawn pursuant to the Offer as of such date. In accordance with the terms of the Offer, on August 31, 2018 and September 12, 2018, the Company purchased all 975,686.154 Shares validly tendered and not withdrawn at a price of \$8.15 per Share, which was the net asset value per share as of August 30, 2018, for an aggregate purchase price of \$7,951,842.20.
